TOPICS: **Determining Residual Chlorine in Drinking Water using a Handheld Analyzer** – DEP Course #7996

Description: This course provides detailed information on EPA Method 334, as it pertains to testing for Chlorine on hand-held meters. This course is for employees who need training on Method 334, both to check the calibration of their hand-held meters and to complete their IDOCs for Chlorine to be in compliance with the state when testing samples for Chlorine. The course will discuss method background, state requirements and deadlines, and allow students to complete hands-on training in class. Students will demonstrate their knowledge by checking the calibration of their meter and performing their own Initial Demonstration of Capability. **NOTE: Please bring your meter to class with you!!**
